Vice Chair Beth Caple made a motion to approve consent agenda items, Supervisor Kevin Davidson second, motion approved.

**CORRESPONDENCE:** Correspondence was reviewed, no action required.

## **RESIDENTS AND GUESTS:**

- Heidi Yokel gave a Fire Department Report. They responded to three medical calls in March. Five EMR's have renewed their license. They attended HazMat training and medical training. They have dry hydrant training on Saturday, May 1.

## **OLD BUSINESS**

- **Road and Bridge:**
  - Chairperson Arrlette Krog reported that when she called the county there is still no date determined for the bridge closure on Melrude Rd. Vice Chair Beth Caple will talk to Northland Construction to see if they can give us an idea on start date.
- **Buildings:**
  - Melrude Fire Hall – The fire department was asked if they could rearrange trucks to eliminate the issue with the OH doors. They responded no, due to state regulations requiring a tanker parked there in order to call it a fire hall. Chairperson Arrlette Krog made a motion to table renovations for the fire hall until additional bids come in and more clarification on the Affordable Rescue Plan to see if we can use some of those funds for the fire hall, Vice Chair Beth Caple second, motion approved.
  - Bass Lake Fire Hall – The fire department asked about having one OH door repaired. The door comes down slow and you have to hold the button so it does not bounce back up. They have tried to realign the sensors with no luck. Chairperson Arrlette Krog made a motion to call Phil's Garage Door Service to repair the door, Supervisor Kevin Davidson second, motion approved. Clerk Cindy Brown will call Phil's Garage Door Service.
- **Cemetery:** One funeral scheduled for June 19.
- **Website:** Nothing new to report.

## **NEW BUSINESS**

- American Rescue Plan – Clerk Cindy Brown reported the township should receive \$20,000 according to the information on the MAT website. The money could arrive as soon as May 11 or as late as July 11. The state has not released criteria on what the monies can be used for but the clerk encouraged the board to put thought into where the money can best be utilized. Clerk suggested possibly insulating the outside of the town hall and putting on new siding and/or installing a HVAC system in the town hall.

- Playground equipment – At this time we will table adding playground equipment.
- Mowing Contracts – Chairperson Arrlette Krog read the two bids received: TAG \$4900.00 and Lee Voigt \$5700.00. After a short discussion the board decided that since they are tasked with being fiscally responsible to our residents, they will award TAG the contract. Supervisor Kevin Davidson made a motion to approve the TAG bid, Vice Chair Beth Caple second, motion approved.
- Election Judge Pay – Clerk Cindy Brown explained that she forgot to add Election Judge pay to the wage update at the Reorganization Meeting and would like the board to consider increasing their pay to \$15.00/hour. Vice Chair Beth Caple recommended, and made a motion, to increase to \$12.00/hour, Chairperson Arrlette Krog second, motion approved.
- Road Review – Chairperson Arrlette Krog read the Road Review notes for the guests present. Several action items were addressed:
  - Fire Wise Grant - Chairperson Arrlette Krog will inquire about criteria required to apply for the grant to replace/add 911 signs, she will report findings to the township and fire department.
  - Mink Rd Grading – Vice Chair Beth Caple made a motion to hire Rodda Excavating to grade the Mink Rd, Chairperson Arrlette Krog second, motion approved. Since we have not yet awarded the 2021 grading contract, she will inform him this is a one-time only request until contract awarded.
  - Grading all township roads – Supervisor Kevin Davidson asked why we don't contract with St. Louis County to maintain our roads. No one has the history as to why we do not use the county for road maintenance. Vice Chair Beth Caple will call the county this month to inquire, and if they are open to providing this service, she will get associated costs so we can do cost comparison.
  - Security light for town hall – Vice Chair Beth Caple called Lake Country Power and adding an LED light to the pole outside the front door will cost \$150.00 for installation, and it will add \$10.50/month to our light bill. There will be no additional costs as Lake Country Power will maintain the light. Supervisor Kevin Davidson made a motion to approve the installation, Chairperson Arrlette Krog second, motion approved.
  - Bass Lake Fire Hall – 2 lights are burned out, Vice Chair Beth Caple will call the electrician to fix.
- Dumpster Days – Chairperson Arrlette Krog made a motion to table setting dates until clerk can call the company to inquire about a Saturday removal, Vice Chair Beth Caple second, motion approved.
- Mosquito Squad – A 30% discount offer expires April 30. Supervisor Kevin Davidson made a motion to hire them to spray at the town hall and Bass Lake fire hall June through August, Vice Chair Beth Caple second, motion approved.
- Portable outhouse for town hall – As in past years we should place an outhouse at the town hall from June through September for community use. Vice Chair Beth Caple made a motion to approve, Chairperson Arrlette Krog second, motion approved.
