**New Business**

Heidi Yokel gave a report on the Fire Department stating they went on three calls that month. She also stated that the EVFD was present at the Melrude Winter Frolic and that there are two members who were starting EMR training.

The posting for lawn mowing was updated to include mowing the section next to the basketball court. Supervisor Arrlette Krog made a motion to plant for lawn Mowing, Chairman Beth Caple second, motion passed.

During the break-in the fireproof cabinet in the office was damaged, Treasurer Elaine Wick stated that she had spoken to Biss Lock Company and the cabinet may be able to be repaired at a lower cost than replacing it. Chairman Beth Caple made a motion to pursue having Biss Lock repair the cabinet, Supervisor Brandon Cavanaugh second, motion passed.

A discussion took place about filing an insurance claim for the break-in. The current cost is around \$1,300.00, and will increase once the safe passcode is change and the fireproof cabinet is repaired. It was decided that filing a claim will be looked at further once all the costs associated are known.

A discussion took place about adding security cameras at the Town Hall. Chairman Beth Caple suggested purchasing Nest cameras and having them installed outside and inside the town hall. A discussion about the legality of having cameras inside a public building where elections and other government functions are performed. Supervisor Arrlette Krog stated that she would like to gather more information and made a motion to table the discussion until then, Supervisor Brandon Cavanaugh second, motion passed.

Clerk McKenzie Clinton announced that she had appointed Cindy Brown as Deputy Clerk.

As there was no further business, Chairman Beth Caple made a motion to adjourn the meeting, Supervisor Brandon Cavanaugh second, the meeting was adjourned at 6:40 P.M.
