Clerks Minutes: Clerks minutes were read and approved. Keith made the motion, seconded by, Kevin motion carried.

New Business: Randee put up postings and e-mailed Keith to put on Web site, and sent out Pamphlets to the contractors sending in bids. Kevin said he will talk to Rick McRae about any questions on the moving of the Pavilion. Kevin will also get the rest of the parts for the sandbox and finish it off.
